## Apply for a UHCCF grant online



Family applies via [UHCCF.org](https://www.uhccf.org).



UHCCF will notify the family of approval within 30–60 days of receiving the application.



Once approved, the family will need to submit a request for payment online for approved medical services/items.\*\*



Payments may be issued to parent/guardian or provider.

## Together, we can change lives

UnitedHealthcare Children's Foundation (UHCCF) offers a helping hand through medical grants, to assist families with medical expenses for their child that are not covered, or not fully covered, by their commercial health plan.

Since 2005, UHCCF has awarded more than 37,000 grants valued at over \$75 million to children and their families across the United States. By 2030, the foundation aims to award our 50,000th medical grant.

## Grants cover a variety of medical expenses\*

Families can use the grants to pay child medical services and equipment such as physical, occupational and speech therapy, counseling services, surgeries, prescriptions, wheelchairs, orthotics, eyeglasses and hearing aids, etc.

**Important reminder:** Once a family incurs a child medical expense, they have 60 days to apply for a UHCCF grant. Upon grant approval, they must use the funds to pay the expense within a year.

## UHCCF medical grants help families focus on what matters most – improving the quality of life of their child.

### See if your child is eligible:

- 1 Child must be 16 years of age or younger at the time of application, living in the United States and facing a clinical condition.
- 2 Child must be covered by a commercial health insurance plan.  
**Note:** Insurance coverage does not have to be through UnitedHealthcare.
- 3 Family must not exceed maximum eligible adjusted gross income as documented on IRS Tax Form 1040.

Family size	Adjusted gross income
2 people	\$65K or less
3 people	\$100K or less
4 people	\$135K or less
5+ people	\$170K or less
